In the context of the coronavirus epidemic (COVID-19), traffic restrictions and containment measures imposed by public authorities, the Board of Directors decided, in accordance with the provisions of Ordinance No. 2020-321 of March 25, 2020 and Decree No. 2020-418 of April 10, 2020, that the Annual General Meeting of AMOEBA on May 28, 2020 and, in the event of a lack of quorum, on second notice on Wednesday, June 24, 2020, will exceptionally be held behind closed doors, without the presence of shareholders, at the Company's registered office.

Under these conditions, shareholders are invited to participate in the Shareholders' Meeting by using the postal voting form or by giving a proxy to the Chairman.

The procedures for holding the Shareholders' Meeting may change depending on health and/or legal requirements. Shareholders are invited to regularly consult the section dedicated to the Shareholders' Meeting on the Company's website http://www.amoeba-biocide.com/fr/informations-reglementaires-et-documents-financiers.

The results of the votes on the resolutions will be posted on the Company's website.

The notice of the meeting, including the agenda and the planned resolutions, was published in the BALO (Bulletin of obligatory legal announcements) of April 22, 2020; the notice convening the meeting was published in the BALO of May 13, 2020.

The documents stipulated by article R.225-83 of the French commercial code are available to shareholders from the moment that the assembly is convened, in line with the applicable regulatory requirements:

• Any registered shareholder can, until the fifth day (inclusive) before the assembly, ask the company to send him these documents. For holders of bearer shares, this right can only be



exercised upon presentation of a statement of participation in the accounts of bearer shares held by the authorised intermediary;

• Any shareholder can consult these documents at the company's headquarters during the 15 days preceding the date of the meeting.



About AMOEBA:

Amoéba's ambition is to become a major player in the treatment of bacterial risk in the fields of water, healthcare and plant protection. Our biological solution is an alternative to chemical products widely used today. Amoéba is currently focusing on the market of industrial cooling towers estimated at ≤ 1.7 Bn ⁽¹⁾ on a global chemical biocide market for water treatment, evaluated at ≤ 21 Bn ⁽²⁾ and on the biocontrol market for plant protection estimated globally at ≤ 1.6 Bn ⁽⁴⁾. In the future, the Company is looking at developing new applications such as chronic wound care, estimated at ≤ 751 million ⁽³⁾ in the USA. Sales of associated products with healthcare, biocides and crop protection are subject to the Company being granted local regulatory market authorizations. The Company is currently in a trial phase for biocidal and plant protection applications and does not market any products.

Created in 2010, based in Chassieu (Lyon, France) with a subsidiary in Canada and in the United States, Amoéba is quoted on the compartment C of Euronext Paris.
